The Licensee MAY:

The Licensee MUST:

6. Store the CCPI materials on any computer, hard drive, tape drive, CD, DVD, or other retrieval system.
7. Transfer, rent, lease, sublicense, or lend the CCPI materials to another person or institution.
8. Collect payment for performing any CCPI programs.
